PERKUAT SINERGI, JASA ARMADA INDONESIA LANJUTKAN KERJA SAMA STRATEGIS DENGAN PELABUHAN BUKIT PRIMA

Jakarta, 13 November 2025. Bertempat di Pelindo Tower, PT Jasa Armada Indonesia Tbk (IDX: IPCM) yang merupakan bagian dari Pelindo Group, tandatangani perjanjian kerja sama dengan PT Pelabuhan Bukit Prima dalam pelayanan jasa penundaan kapal di Terminal Untuk Kepentingan Sendiri (TUKS) milik PT Bukit Asam Tbk.
